Deadline to secure booth is October 13, 2017

- The fee to set up and rent a vendor booth is \$25 per booth.
- Credit Card and check payments for vendor booth space are accepted and checks should be made payable to United in Pink, Inc.
- Vendor booth fees are non-refundable and expected upon submission of an application to United in Pink, Inc.
- Vendors will be supplied one (1) tent, one (1) six foot (6') table and two (2) chairs.
- Vendors must supply their own table covers and any other items needed for set-up.
- Vendors are responsible for collecting their own money and securing the safety of their money. United in Pink, Inc. will not be responsible for any money lost whatsoever and does not guarantee the safety of vendors' funds or property.
- Vendors may begin set up by 7:00 am on the Wesleyan College Quad grounds located in front of Porter Auditorium on Wesleyan's campus. All cars must be removed from the quad by 7:30 am, as this is on the race route. Vendors listed to operate from 8am-11am.
- Vendors must leave the area assigned to the vendor in the same condition it was found.
- Vendor may supply business cards, brochures, flyers or coupons for race packets. All items to be included in race packets must be delivered to the United in Pink, Inc. office, located at **1515 Bass Road, Suite H, Macon, GA 31210** by October 13, 2017.
